Sept. 24 Program at Inn on the Park:

In July of this year, Vincent O'Hern, Jr., sold Isthmus Publishing to Jeff Haupt, Craig Bartlett and Mark Tauscher. Haupt, along with former owner Vince O'Hern, Jr., will be speaking at our September 24 Rotary luncheon at the Inn on the Park and will share their experiences during the transition period.



Vincent O'Hern, Jr. received a BS Degree from Northwestern University's Medill School of Journalism. He was a Peace Corps Volunteer in Liberia, West Africa and came to Madison in 1968 when he was a recruiter for the Peace Corps Public Affairs division. Following that position, he worked at a variety of jobs over the next several years including taxi driver, bartender and band manager. In 1975, he partnered with local journalist Fred

Milverstedt and launched *Isthmus*. O'Hern has spent the intervening years leading the publication which has won numerous journalism awards. Vincent is married to fellow Rotarian Linda Baldwin (who graciously assisted with the arrangements for this presentation).

Jeff Haupt is an entrepreneur, publishing and sales executive, and a successful businessman. After graduating from the UW in 1995, he headed west to start up a custom publishing company in the Denver/Boulder, CO, area. While there, he also founded and oversaw a franchise of The Onion Newspaper. The Onion brought him back to Madison in 2005 to direct all operations and sales in five regional markets across the nation. In 2010, he founded the Red Card Meal Plan, an off- campus meal plan for students that is now accepted at 85 restaurants and Fresh Madison Market. In 2013 Red Card launched Wisgo, an online food ordering platform that competes with

Grubhub and Eatstreet. Jeff is married to Rana Leer Haupt, a PA at the UW Spine Clinic, and has two daughters, ages 6 and 10.

"Proud History – Bright Future: 75 Years and Just Getting Started" Ralph Russo, Director, Wisconsin Union Theater

Ralph Russo has been with the Wisconsin Union for more than 30 years and is Director of the Wisconsin Union Theater. In this role, Mr. Russo oversees much of the Union's cultural, artistic and entertainment programming which includes the newly renovated Wisconsin Union Theater. His talk reviewed the recently completed renovation of the theater. The theater is a result of the vision and persistent work of former Downtown Rotarian Porter Butts who made the

theater a reality exclusively through private fundraising efforts during the Great Depression!

Mr. Russo covered the theater's history, highlighted by several anecdotes of presidential visits and even the appearance twice by a Stradivarius violin. The instrument was played in a 1958 Union Theater concert by Michael Rabin. In the 2000's virtuoso violinist Midori noticed 'her' violin in a picture back stage. It was the same Strad!

Renovation of the union theater included extensive heating and cooling work, construction of new rehearsal spaces, a new entrance on Langdon Street and a smoothing of the walkway from that lobby to the theater entrance on the lake side of the building. The theater renovation and lakeshore path represent completion of the project's Phase 1.

Phase 2 is set to begin summer of 2015 and requires two years to complete. Alumni Park and renovation of the Terrace are included in this phase. There are still funds to raise to cover Phase 2. A final public input session on the project is scheduled at Tripp Commons at the Union, Monday, September 22nd 5-7pm open to the public. Rotary Senior Service Award Presented to Wheels for Winners Senior Team Introduced by Dean Nelson -- September 17, 2014

It is our privilege to honor six seniors who have donated hundreds of hours of service for the Wheels for Winners, earn a bike program.

Wheels for Winners' mission is to provide bicycles to individuals, primarily youth, who complete at least 15 hours of community service. Upon completion, they can pick out a bike, bike helmet, bike lock, and City of Madison bike registration. These are given to the earners free of charge.



Used bikes are donated and volunteers overhaul them to get them to perfect working condition. About 175 – 200 bikes are given out each year, all accomplished with 100% volunteer staff. Our Club's foundation has provided a grant to Wheels for Winners in 3 of the last 5 years.

The individuals being recognized today come to the Wheels for Winners shop to work on the bikes Monday and Wednesday afternoons all year round. And, Charlotte has been there too for the past 21 years to help with all the paperwork, applications, forms, bike registration, and inventory.

I asked them why they do this work. Clearly, it is a time of joy and personal satisfaction when it's time to fit a kid with a bike, and talk with them about bike maintenance and safety. Remember when you got your first bike? A day to remember.

These folks have the volunteer spirit, and when they are not at Wheels for Winners, they are often at other agencies to contribute their good talent. Charlotte has received from President Bush the Presidential Call to Service Award for 4,000 hours of volunteer service. Charlotte Marshall, Fred Appleton, Walt Brinkman, Jim Connors, John Cronn and Dave Smithson are the individuals we are recognizing today.



They are an inspiration to us in serving others! We appreciate all that they have done to serve our community, and it is an honor to present this group with our Rotary Club of Madison Senior Service Award. Congratulations.

Annual Swarsensky Humanitarian Award Nominations Due Oct. 1



Nomination forms for our annual Manfred Swarsensky Humanitarian Service Award are now available, and the deadline to submit nominations is October 1 in the Rotary office. The selected recipient of this year's award will be introduced during our November 12 Rotary meeting.

The award identifies and honors individuals who, through their voluntary efforts, have made a particularly outstanding contribution to humanitarian service in the greater Madison community, in the tradition so well exemplified by the life of Rabbi Swarsensky. The awardee may have served the community through a single community agency, or service, or

many. The nominator should outline specifically how the candidate meets the criteria for the award. In addition to the distinction of the award, it provides a \$2,500 grant from the Madison Rotary Foundation to the charity chosen by the awardee.

Past recipients include Mercile Lee in 2013, Melanie Ramey in 2012, Steven Morrison in 2011, and Nancy Abraham in 2010. A complete listing of past recipients of this award is listed on page 64 of our membership roster.
